# OWCP Claims under the Federal Employees' Compensation Act (FECA)

## **Traumatic Injury (CA-1 form)**

- A traumatic injury is identifiable by time and place of occurrence and member of the body affected; it must be caused by a specific event or series of events within a single day or work shift.
- Time limit for filing, an employee has up to three years to file a claim for traumatic injury. However, in order to be entitled to Continuation of Pay (COP), a Form CA-1 should be filed immediately with the supervisor or within 30 days from date of the injury.

## Occupational Illness/Disease (CA-2 form)

- An occupational illness or disease is a condition that happens over a period of time, over more than one work shift. It is usually not identifiable by date, time or place, but just occurs in the performance of duty.
- Time limit for filing, an employee has up to three years to file a claim for Occupational Illness/Disease. A Form CA-2 should be filed as soon as possible with the supervisor or within 3 years.
- These types of claims take longer for DOL to adjudicate. Any benefit the employee is entitled to receive is provided after the claim is accepted by DOL. Therefore, employees should seek medical attention through their primary care doctor, or receive a referral to the Occupational Health Clinic, using their own health insurance. COP is not paid for these types of claims. The employee must use his or her own sick leave, annual leave, or leave without pay. Compensation will be payable after the claim is accepted by DOL. The first three days in a non-pay status are waiting days and no compensation is paid for these days unless the period of disability exceeds 14 calendar days or the employee has suffered a permanent disability.

## How to File a Claim (see step by step instructions for your command)

It is recommended that you use the ECOMP system (Contact our office if you need help)

• Filing a CA1 or CA2 by electronic submission directly in DOL's ECOMP system:

Once you complete the claim form in DOL's ECOMP system, please notify your supervisor that you submitted a claim in ECOMP for their review. Your supervisor will receive an email with a link from ECOMP (noreply@ecomp.dol.gov) to access your claim and complete the supervisory portion of the claim form. Once completed by the supervisor, the CNIC FECA Office will receive an email to complete the agency review portion of the claim and complete the claim submission process to DOL. Our office will provide a claim# to the employee via email in about 1 day.

#### Submitting a hard copy/signed form is an option if you are unable to submit via the ECOMP system.

 Filing a CA1 or CA2 by hard copy submission: Download forms at link: https://www.dol.gov/owcp/dfec/regs/compliance/forms.htm

Do not delay filing a claim form. If you are unable to navigate through the DOL's ECOMP system to file a CA1 or CA2, you may still complete page 1 of the hard copy form, print/sign/date the form and immediately provide it to your supervisor for completion of page 2. Your supervisor can scan the hardcopy completed claim form and email the form (encrypted) directly to the CNIC FECA office (see POCs listing). Your claim form will be assigned to one of our injury compensation specialists in the office who will provide you guidance throughout the process. The claim form and any supporting documentation will be reviewed, and then submitted by our office to DOL in their ECOMP System. The claim# will be provided to the employee via email in about 1 day.
