RMKS/1. THIS NAVADMIN PROVIDES GUIDANCE FOR SUBMISSION OF FY-12 COALITION OF
SAILORS AGAINST DESTRUCTIVE DECISIONS (CSADD) SEA AND SHORE CHAPTER OF THE YEAR
NOMINATIONS TO NAVY REGION MID ATLANTIC. ALL ACTIVE, RESERVE AND RESERVE
OFFICERS' TRAINING CORPS UNIT CSADD CHAPTERS ARE ELIGIBLE.

2. NOMINATIONS FOR CSADD SEA/SHORE CHAPTER OF THE YEAR AWARDS SHALL INCLUDE ONLY
ACTIVITIES AND SUCCESSES THAT OCCURRED DURING FY-12. NOMINATIONS SHALL BE
SUBMITTED BY THE UNIT COMMANDER OR DESIGNATED REPRESENTATIVE, WHO WILL FORWARD
NOMINATIONS TO THE REGIONAL COMMANDER.

3. IF A COMMAND HAS NOT REGISTERED ITS CHAPTER, IT MUST DO SO, AS OUTLINED IN
REF A, PRIOR TO SUBMITTING THE NOMINATION. CSADD CHAPTERS CAN VERIFY
REGISTRATION STATUS BY CONTACTING THE POINT OF CONTACT LISTED ON THIS MESSAGE.

4. THE REGIONAL CHAPTER WILL COMPILE ALL NOMINATIONS FROM WITHIN NAVY REGION MID
ATLANTIC, SELECT THE TOP SEA AND SHORE CHAPTER AND FORWARD THOSE PACKAGES WITH
REGIONAL COMMANDER ENDORSEMENT TO MPTE FLEET MASTER CHIEF, AS DEFINED IN NAVADMIN
207/12, PARA 4.

5. ONE ORIGINAL AND ONE COPY OF THE NOMINATIONS ARE TO BE MAILED BY EACH UNIT TO
COMMANDER NAVY REGION MID-ATLANTIC NO LATER THAN 1 OCTOBER 2012. SUBMISSIONS
