DUTIES AND RESPONSIBILITIES:

Serves as the leader of lifeguard crew. Monitors rotation schedules and work performance, issues directives and may recommend personnel actions to the manager. Performs rescue procedures when necessary. Administers emergency first aid and/or CPR, when necessary. Provides written reports pertaining to all incidents that occur while on duty. Closely observes and monitors the actions and conduct of customers in and around the swimming pool. Provides information to customers regarding safety regulations and procedures and enforces established rules and regulations. Tests chemical conditions of water and enters data into appropriate logs. Assists in the daily operation of keeping facility clean and properly maintained. During the absence of the Aquatic Center Manager, assumes day to day managerial responsibility and authority over the facility. May instruct swim lessons if properly certified and so directed by the supervisor. Performs other related duties as assigned.

MINIMUM QUALIFICATIONS:

Current Lifeguarding, CPR and First Aide certification is required. Must be 18 years of age and capable of exercising control over a group of people. Must maintain a level of physical conditioning equal to swimming 200 meters in less than 5 minutes.

IMPORTANT: MUST SUBMIT COPIES OF CURRENT LIFEGUARD/FIRST AID AND CPR CERTIFICATIONS WITH APPLICATION. FAILURE TO DO SO WILL PREVENT YOUR APPLICATION FROM BEING CONSIDERED

SPECIAL REQUIREMENTS:

This position is subject to completion of a satisfactory background check and/or National Agency Check (NAC) in accordance with NAVFAC policy. Must be available to work days, evenings and weekends.
