8. What are the ages of your children? Are they U.S. Citizens?	
9. Are your family members, up to grandparents, U.S. Citizens (if married, include your spouse's family members)?	
10. Have you maintained or do you currently maintain ties of affection, obligation or kinship to any individual of foreign birth or who is not a U.S. Citizen? If yes, what country?	
11. Have you had or do you currently have financial interests, holdings or dealings with a foreign based business?	
12. Have you owned or do you currently own property or a bank account in a foreign country?	
13. Have you ever filed for bankruptcy?	
14. Have you ever been late/slow paying creditors 30 days or more?	
15. Are there any negative items on your credit report?
