1. The information contained herein is furnished for the purpose of acquainting each owner of a private motor vehicle with the obligations he/she incurs upon registration of his/her vehicle with the Motor Vehicle Registration Office (MVRO) of this command. It is the personal responsibility of the individual to discharge these obligations:

- * Applications for registration may be submitted to the MVRO along with proof of the required insurance. Applications or renewals must be submitted one month prior to the registration expiration month.
- * License plates issued upon registration will be permanently mounted in clear visible positions in the front and rear of the vehicle for which issued. The theft or rendering illegible of either or both plates must be reported immediately to the cognizant MVRO, and a new set of plates purchased.
- * Vehicles must be inspected and approved by a certified official who will issue a certificate of successful completion of inspection.
- * In accordance with NAVSUPACT NAPLES INST 11240.19 series, it is the personal responsibility of each individual to maintain insurance for the duration of the vehicle's presence in Italy. Such an insurance policy must provide the following coverage:
 - € 774,685,00 against personal injury and property damage.
- * Alteration of the body or change of color or the vehicle will not be accomplished without receiving authorization from the cognizant MVRO.
- * Failure to maintain valid registration, insurance, or to pass safety inspection will result in the cancellation of the license plate, gas card, driver's license and all other privileges rendered by this office.
- * Immediately report the loss or theft of your registration to the cognizant MVRO. Your registration document is very valuable and must be carried with you at all times. Failure to do so may result in serious complications with the Italian authorities. **TAKE CARE OF YOUR REGISTRATION DOCUMENT!**
- * AFI vehicles, or parts thereof, may not be sold or donated to Italian national firms. Failure to comply with the above will result in the payment of customs duty which in some cases will exceed the value of the vehicle concerned.
- * Upon departure from the area the vehicle must be properly disposed of by one of three methods of handling:
 - Exportation
 - Sale to another individual eligible for registration
 - Transfer to the U.S. Government for scrapping.
 - **AFI plates and Cover Plates** must be turned in to CMVRO before exporting the vehicle or selling the vehicle to someone outside the AFI system.

Powers of Attorney are forbidden except under extreme emergency conditions!

* Owners of vehicle registered AFI white plates will be authorized a total of up to 400 liters of duty free gasoline a month, in accordance with NAVSUPACT NAPLES INST 10340.1 series. No additional allowance is authorized for second cars.

I state that neither I nor a member of my family has another car registered with AFI or Italian license plate for which a gas card has been issued except as listed on the front of this form.

- 1. AUTHORITY: 5 USC; 10 USC 6161; 10 USC 2774 as amended by Public Law 92-453; and NAVSUPACT NAPLES INST 12735.1 series.
- 2. PRINCIPLE PURPOSE(S): To assist in the arrangement, supervision and administration of vehicle registration.
- 3. ROUTINE USE(S): Law enforcement, Congressional inquiries; Disclosure required by International Agreements; Disclosure to local taxing authorities; Disclosure to the office of Personnel Management; Disclosure to the Department of Justice for litigation; Disclosure to Military Banking Facilities Overseas; Disclosure of information to the General Service Administration; Disclosure to the National Archives and Records Administrations and Disclosure to Italian Customs Officials.
