1. Purpose. To provide ordering and releasing procedures to U.S. military installations importing tax-free tobacco products.

2. Cancellation. NAVSUPPACT NAPLES INST 4400.5D.

3. Background. U.S. Naval Support Activity (NAVSUPPACT), Naples, Italy, validates tax-exempt tobacco requirements per references (a) through (g). NAVSUPPACT Naples assigns an importation number (MONITAL) to each tobacco purchase order. After the Italian Government certifies purchase orders, NAVSUPPACT Naples certifies that the order is approved for importation. The order is then forwarded to the U.S. supplier.

GUIDELINES ON REGULATIONS, POLICIES, AND PROCEDURES

1. Ordering Procedure.

a. Prepare separate purchase orders for each delivery consigned to different customs or command districts (i.e. Naples, Leghorn, Vicenza, etc.).

b. By the twentieth of each month, forward the original and seven copies of each purchase order to U.S. Naval Support Activity (NAVSUPPACT), Naples, Italy (Code N4P). Tobacco orders must be processed at least four months prior to the date the product is required in Italy. Include a cover letter that identifies the ordering installation, the quantity of the tobacco product being ordered (e.g., number of packages of cigarettes or cans of snuff), number of U.S. military, civilian, and family member personnel (over 18 years old) attached to the ordering installation at time the purchase order is placed and entitled to tobacco ration, and the required delivery date in Italy.

c. The quantity of tobacco products ordered each month cannot exceed the formula of 1,200 grams or 1.2 kilograms (Kg) (60 packages of cigarettes), multiplied by the number of U.S. military, civilian, and family members entitled to a tobacco ration and attached to each military installation.

d. Each tobacco product purchase order must clearly indicate the net weight in kilograms for each line item in the purchase order. A copy of the purchase order and cover letter must be forwarded to the Receiving/Transportation Officer responsible for preparing the documentation required by Monopoly or customs officials for the verification or inspection of the tobacco shipment upon its arrival in Italy.

2. Releasing Procedure for Receiving/Transportation Officers

a. Obtain from the ordering office the number of U.S. military, civilian, and family member personnel entitled to a tobacco ration that are attached to the military installation.

b. Attach a declaration of responsibility to the Customs Form 302 for forwarding to the customs officials, per enclosure (2).

c. When preparing the declaration of responsibility, use the same numerical data of the cover letter, which accompanies the

advance copy of the purchase order. Use the MONITAL importation number printed on the outside of the tobacco-packing box.

d. Maintain an accurate record of the quantity of cigarettes and other tobacco products received per purchase order, MONITAL authorization number, and the number of eligible personnel justifying the size of the order. These records are important to facilitate customs clearance of these shipments.

e. Per reference (f), customs clearance for imported tax-free foreign tobacco products must be carried out through the customs office located closest to the ordering military command.

f. Receiving activities will be responsible for arranging at destination with the State Monopoly office located closest to their installations for the required monopoly verification.

3. Movement of Tax-Free Tobacco. Per reference (f), the emergency transfer of tax-free tobacco products between military installations in Italy is authorized on condition that Customs Form AE-302 accompanies the product. This customs form must be presented in advance to the customs office located closest to the final receiving command. Reference (f) also requires the insurance coverage for the shipment to include provisions for the payment of customs fines in case the product is stolen in transit. The total quantity of tobacco products transferred to a military installation must not exceed the maximum allowance of 1,200 grams or 1.2 Kg per month, multiplied by the number of personnel entitled to receive the product.

4. Per reference (b), U.S. tobacco vendors are required to use the MONITAL red seal stamps on each cigarette package manufactured in the United States for consumption by U.S. Forces in Italy. The MONITAL importation number of each tobacco product purchase order assigned by NAVSUPPACT Naples, Tax-free Products Division, must be printed on the outside of each packing case. Per reference (g), the MONITAL red seal stamp is also required on each pipe tobacco and cigar package.

5. Warning. Tobacco shipped into Italy without the red MONITAL seal stamp, quantities that exceed the amount listed on the purchase order, or shipments resulting from purchase orders submitted directly to U.S. based suppliers are considered illegal and will be impounded by customs officials. The ordering activity may also be fined. Such tobacco products will be

returned to the U.S. supplier or destroyed locally. If a determination is made to return the over-shipment to the U.S. vender, payment of the transportation cost will be negotiated between the vendor and the ordering officer.
