



# NATO FORCES FUEL CARD

**Request to participate in the Forax Tax Free Fuel Card Program:**

- A. I understand that the Navy Exchange will arrange for FORAX to bill the NEX directly for the monthly cost of fuel, free from Italian national, provincial, regional and local taxes to the extent authorized by law or agreement. PLEASE INITIAL \_\_\_\_\_
- B. I understand that the Navy Exchange is acting as my agent and initially responsible for payment of my FORAX bill. I further understand that the Navy Exchange will subsequently debit my credit card on a bimonthly basis, a prerequisite for my enrollment in the program. PLEASE INITIAL \_\_\_\_\_
- C. I understand that unpaid balances will cause immediate deactivation of my fuel card. The reactivation of the card will be processed after review of my billing status. PLEASE INITIAL \_\_\_\_\_
- D. I will provide the NEX with my information (name, NATO license number, license plate number, and email address to receive email notification) PLEASE INITIAL \_\_\_\_\_
- E. I understand that FORAX is providing this service. Resolution of any disputes in regards to card malfunction will be with FORAX) thru the Help Desk. Resolution of any disputes in regards to billing will be with the NEX thru the QoL office. PLEASE INITIAL \_\_\_\_\_
- F. I authorize NEX to disclose to FORAX my information (as indicated above) for registration for the Tax Free Fuel Card Program. PLEASE INITIAL \_\_\_\_\_

It is our policy to include confidentiality and data protection provisions in the contracts with these entities. We restrict access to your nonpublic personal information to those employees who have a need to know or the performance of their duties. We maintain physical, electronic, and procedural safeguards that comply with federal regulations to guard your nonpublic personal information. Providing this information is voluntary, but if not provided, we may not process your request for the tax free fuel benefit.
