Subj: RATION-IN-KIND FOR DRILLING WEEKEND NAVY RESERVISTS
(SELRES)

Ref: (a) NAVSUP P-486, para 2101-2104

1. Purpose. To establish policy and guidelines for providing rations-in-kind (RIK) for drilling weekend Navy Reservists (SELRES) by Joint Base Pearl Harbor-Hickam (JBPHH) General Mess in accordance with reference (a).

2. Cancellation. NAVSTAPEARLINST 4061.9A

3. Background. Reference (a) authorizes RIK to be provided to Naval Reserve personnel performing drills.


4. Action

a. Monthly, Naval & Marine Corps Reserve Center (NAVMACORESCEN) Pearl Harbor will provide to JBPHH Food Service Officer an updated listing of Navy enlisted reserve personnel drilling to establish authorized personnel entitled to RIK for drilling weekends.

b. NAVMACORESCEN Pearl Harbor will provide to JBPHH Food Service Officer a list of authorized drill weekends for each month one week prior to the start of the month.

c. JBPHH, Galley Supervisor will be provided the master list of Navy enlisted reserve personnel drilling and listing of authorized drill weekends. On drill weekends, the Galley Master at Arms (GMAA) will check the member's identification (ID) card against the master listing and list of drill weekends to validate member's entitlement to RIK. For those SELRES who are making-up a drill weekend, the individual will show the GMAA his/her ID card and the signed copy of his/her unit CO's authorization for make-up drill.

d. SELRES drilling personnel will insert Common Access Card (CAC) into the CAC reader and enter personal pin number for validation and certification.



1. Purpose. To establish policy and guidelines for providing rations-in-kind (RIK) for drilling weekend Navy Reservists (SELRES) by Naval Station, Pearl Harbor General Mess in accordance with reference (a).
2. Cancellation. NAVSTAPEARLINST 4061.9.
3. Background. Reference (b) authorizes RIK to be provided to Naval Reserve personnel performing drills. References (c) and (d) provide for validation and certification of Meal Signature Record (NAVSUP Form 1291) for entitlement to RIK.
4. Action
 - a. Monthly NAVMARCORESCEN, Pearl Harbor will provide to NAVSTA, Pearl Harbor Food Service Officer an updated listing of Navy enlisted reserve personnel drilling to establish authorized personnel entitled to RIK for drill weekends.
 - b. NAVMARCORESCEN, Pearl Harbor will provide to NAVSTA, Pearl Harbor Food Service Officer a list of authorized drill weekends for each month one week prior to the start of the month.
 - c. NAVSTA, Pearl Harbor Galley Master at Arms (MAA) will be provided the master list of Navy enlisted reserve personnel drilling and listing of authorized drill weekends. On drill weekends the Galley MAA will check the member's ID card against the master listing and list of drill weekends to validate member's entitlement to RIK. For those SELRES who are making-up a drill weekend, the individual will show the Galley MAA his ID card and the signed copy of his unit CO's authorization for make-up drill.
 - d. SELRES drilling personnel will legibly sign the NAVSUP Form 1291 with their last name, SSN and drill unit prior to entering the serving line.
