Subj: PERFORMANCE AND SUPERVISION OF HARD LABOR WITHOUT
CONFINEMENT

Encl: (1) Performance of Hard Labor Without Confinement

1. Purpose. To establish procedures for performance and supervision of hard labor without confinement adjudged as punishment by courts-martial upon personnel attached to this command.

2. Cancellation. NAVSTAPEARLINST 5810.1C

3. Background. Reference (a) provides that hard labor without confinement may only be imposed pursuant to a sentence adjudged at a court-martial. Joint Base Commander, Joint Base Pearl Harbor-Hickam, Pearl Harbor, is responsible for designating the place and character of the hard labor performed by persons attached to this command who have been sentenced to hard labor without confinement. Reference (b) provides that hard labor without confinement commences when ordered executed, ordinarily on the date of the convening authority's action. No person will be excused or relieved from any other military duty to perform hard labor.

4. Discussion

a. Reference (c) provides that persons sentenced to hard labor without confinement will do so daily, except Sundays, until the sentence is satisfied. Sundays will be included when computing the date the sentence terminates. Hard labor must be differentiated from extra duties.

b. Hard labor at this command will be performed after completion of regular assigned duties for no more than three (03) hours per day.

c. Unless in a duty section or restricted status, service member may commence normal liberty upon completion of their daily hard labor assignments.

5. Action


a. Personnel awarded hard labor without confinement will normally report to the Chief Master-at-Arms who will monitor daily hard labor assignments in accordance with reference (c). The Legal Office will maintain enclosure (1).

Normal hard labor hours are:

Monday through Friday: 1700-2000
Saturday: 1300-1600
Sunday: NONE

b. Personnel who perform normal duty on Ford Island, Magnetic Silencing Facility, or Service Craft shall perform hard labor within their respective division/work centers. Performance of hard labor will be coordinated with the Staff Judge Advocate's Office. The Executive Officer may direct deviations in specific cases.

c. Respective division officers (or their delegates), or the Chief Master-at-Arms will supervise performance of hard labor and will maintain a daily log showing the name of each individual performing hard labor, tasks assigned/completed, dates and hours performed.
