Subj: PREVENTIVE MEDICINE AND ENVIRONMENTAL SANITATION PROGRAMS

Ref: (a) NAVMED P-117, Chap 22
(b) NAVMED P-5010, Manual of Naval Preventive Medicine

1. Purpose. To promote the health and hygiene of Hawaii area Naval personnel, and to provide preventive medicine and environmental sanitation support to local area commands. This instruction has been revised in its entirety.

2. Cancellation. COMNAVBASEPEARLINST 6240.7B

3. Background. The Commanding Officer, Naval Health Clinic Hawaii (NHCH), Pearl Harbor in accordance with reference (a), is responsible for providing health care to local area commands and advising Commanding Officers on matters relating to preventive medicine and environmental health. Reference (b) sets forth preventive medicine standards and guidelines that are applicable throughout the Naval establishment.

4. Policy. Compliance with the guidelines and standards outlined in reference (b) is mandatory and required of all Naval personnel within the Hawaii area.


5. Action

a. Commanding Officer, NHCH, Pearl Harbor shall:

- (1) Provide technical assistance and instruction.
- (2) Perform routine, unannounced environmental sanitation inspections of command facilities, including food service facilities, community service facilities, living spaces, and recreational facilities.
- (3) Report results of all inspections to the appropriate Commanding Officer(s). Any inspection that uncovers a life threatening discrepancy will be reported to the appropriate Commanding Officer(s) immediately by phone.

b. Commanding Officers have overall responsibility for the health and welfare of their assigned personnel, and shall ensure that persons under their cognizance are aware of, and comply with, requirements and standards set forth in reference (b) and other directives and publications pertaining to preventive medicine and environmental health programs.

c. Food Service manager, Civilian or Club/Mess Managers, will provide a written report of all corrective actions taken on violations (five defect points or more within seven days of inspection) to the responsible Commanding Officer(s) with a copy to the Preventive Medical Department, NHCH, Pearl Harbor.
