### PRIVACY ACT STATEMENT 個人情報保護について

AUTHORITY: Executive Order 10450, 9397; and Japan Law Concerning Protection of Personal Information (Law No. 57 of 2003).

PRINCIPAL PURPOSES: To record Personal Information for the purposes of executing the business operations of the U.S. Forces, Japan and protection of human life, safety and property, NOTE: Records will be securely maintained in either an electronic or paper form.

## 6. Task List:

1. Patrols. Patrols by an assigned government vehicle and foot patrol of all Commander Fleet Activities Sasebo (CFAS) property in accordance with Standard Operating Procedures (SOPs) and instructions, paying close attention to physical condition of installation as a whole.
  - a. Conducts Government vehicle inspections and minor repair (flat tire) prior to use for safety and proper condition and report discrepancies (dent, scratches, damages) to duty Guard Supervisor(s).
  - b. Conducts checks for protective lighting ensuring all light are operational. Make timely reports to duty Guard Supervisor(s) if one is discovered not functional.
  - c. Performs physical security checks of all areas assigned to CFAS and in/around his/her posts based on a designated check sheet to ensure they are properly secured and to prevent unauthorized entry/theft/damage. Area/property includes designated gates/fence, storage area, parking lots, open field, barracks, dry dock, office area and other similar spaces. In the event of higher threat condition, vigorously performs this function on a continuous basis.
  - d. Reports all suspicious individuals, incidents and traffic accidents occurred on or near his/her areas of responsibility to duty Guard Supervisor(s) and Security Dispatcher using portable radio within the chain of command.
2. Sentry at Entry Control Points (ECPs). Stands at designated posts of CFAS property staying alert to conduct the following in accordance with SOPs and instructions. Must take appropriate actions as trained and directed as the situation may warrant in case of an emergency.
  - a. Challenges all traffic, vehicle and pedestrian entering CFAS property including in the vicinity of his/her post. Identifies driver and pedestrian through their authorized identification cards, badges and access lists in accordance with SOPs, instructions and directions. Apprehends unauthorized visitors, takes appropriate minor corrective action(s) or reports other incidents to duty Guard Supervisor (s) or Security Dispatcher immediately using portable radio within the chain of command and awaits arrival of proper personnel to correct the irregularity detected.
  - b. Conducts vehicle inspections on incoming vehicles and issue a temporary vehicle pass (V-pass) or an appropriate permit in accordance with SOPs and instructions. Maintains logs and other records to identify persons and vehicles upon issuance of a temporary vehicles pass or inspection card. Makes appropriate written and oral reports as needed to establish required official records of incidents encountered.
  - c. Requires to upload/download the weapon in strict compliance with the Clearing Barrel Instruction in a manner using due precautions and stay awake including their break time when armed to ensure accountability of assigned weapon and ammunition. Required to be in proper uniform wearing authorized accouterments and properly groomed.
