TASK LIST

Warehouseman, #2299, BWT 2-4

1. Processes all applicable material. This includes receipt, storage and issue/turn-in of all stock material for processing to contractors.
2. Receive and unpack items, checking receipt documents to insure that correct items are received in quantities indicated.
3. Segregates items and stores in proper area in accordance with accepted storage practices with consideration to such factors as shelf life, deterioration characteristics and category of material.
4. Examines stock periodically to identify items in need of reconditioning/repackaging or replacement.
5. Upon receipt of shipment orders, remove items from storage and forwards to appropriate activity.
6. Makes physical inventory of all material on a periodic basis. Work involves light and heavy. lifting (at least 25kg) and sustained movement in both inside and outside areas. Operates forklift to stock and pull materials from the storage racks in the warehouses and deliver HAZMAT to SSRF MAZMAT lockers. Work is primarily inside.

Performs other related or incidental duties as assigned.

Must have GOJ ordinary vehicle driver's license (AT limited is NOT acceptable), GOJ large-sized special purpose vehicle driver's license, and GOJ certificate of completion of training for forklift operation.
