AUTHORITY: Executive Order 10450, 9397; and Japan Law Concerning Protection of Personal Information (Law No. 57 of 2003).

PRINCIPAL PURPOSES: To record Personal Information for the purposes of executing the business operations of the U.S. Forces, Japan and protection of human life, safety and property, NOTE: Records will be securely maintained in either an electronic or paper form.

6. 職務内容 Duties

The position will serve as Manager of the Weight Handling Equipment (WHE), Base Support Vehicles and Equipment (BSVE) Branch Code PRA33, NAVFAC Far East NAVFACFE). The incumbent reports to the Deputy Director of BSVE Branch for all management activities pertaining to work processes, resource allocation, technical, and program management of WHE Program at Naval Air Facility Atsugi. This position is designated to serve as On-Site Manager, Safety/Health Manager, and WHE Program Manager for BSVE and will be assigned as the Alternate Certifying Official for WHE. The incumbent is responsible for administering, direction of contract crane packages and execution of inspection, testing and certification of WHE, and Civil Engineering Support Equipment (CESE), i.e., boom, high-lift and aerial service trucks and equipment for BSVE and other shore activities. The incumbent will responsible for operations of crane/rigging services to support the mission of the BSVE Branch.

Serves as the Weight Test and Certification Director for all WHE, and CESE. In that capacity takes direction in setting priorities, requirement compliance, marketing services and promoting a strong customer focus. The incumbent is responsible for the complete inspection, weight test and certification of WHE, CESE assigned to BSVE and external customers. Provides technical review of inspection reports, specifications and technical instructions to assure necessary standards of quality and reliability are maintained for audit requirements as set forth in NAVFAC P-307. BSVE Branch also provides necessary information as required to Contracts Division in the preparation of specifications for repair and maintenance contracts.

Gives feedback, advice, counsel or instructs employees on work and administrative matters.

Assures that personnel assigned responsibilities are permitted adequate time to perform those duties, attend meetings and training required by their collateral duty assignment. The incumbent is responsible for the safe operation of the weight handling program.

Inspection, monitoring corrective work, testing and certification of weight handling equipment in Categories I, II, III, and IV as prescribed in NAVFAC P-307 is the responsibility of the Division. Testing and inspections of construction and allied equipment is in accordance with NAVFAC P-300. All inspection and testing is accomplished and properly documented to ascertain that the performance of the equipment conforms to safety and operational requirements. Appropriate equipment history record files are maintained for each item of equipment. Specification data sheets are used for checking dimensions and measurements for wear, adjustments, setting, tolerances, etc. Particular emphasis is directed in the inspection of electrical, mechanical, and structural components. The incumbent recommends certification by the Certifying Official only when all requirements have been met. Ensures all equipment operates efficiently and in compliance by inspection, testing and certification of all BSVE and customer owned WHE in accordance with applicable requirements.

Participates with Division Directors and Engineering personnel in resolution of technical problems related to maintenance, repair and alteration of weight lifting and handling equipment.

When plans or working drawings are required for repairs, alterations, modifications and replacement of weight handling equipment components, information will be provided to the Engineering Department for the preparation of required drawings. Personal contacts include engineers and managers of PWD Atsugi, external WHE customers, NAVFACFE Regional Program Manager, other activities managers and headquarters staff at NAVFACFE. Additional contacts include manufacturers of weight handling equipment and component parts.

Manages the Department's crane and rigging operations to ensure that such services are responsive, cost effective, high quality, and safe.

Performs other related or incidental duties as assigned. The incumbent may be required to fill in for the BSV&E Deputy Director during his/her absences.
