### PRIVACY ACT STATEMENT 個人情報保護について

AUTHORITY: Executive Order 10450, 9397; and Japan Law Concerning Protection of Personal Information (Law No. 57 of 2003).

PRINCIPAL PURPOSES: To record Personal Information for the purposes of executing the business operations of the U.S. Forces, Japan and protection of human life, safety and property, NOTE: Records will be securely maintained in either an electronic or paper form.

## 6. 職務内容 Duties

1. Prepares design plans, specifications and detailed cost estimates for all mechanical engineering projects, and coordinates with other engineers or leading project teams on multiple discipline projects. Uses AutoCAD whenever feasible to prepare engineering designs. Provides liaison with official and private Japanese technical organizations, contractors, manufacturers, etcetera on mechanical engineering matters pertaining to design and costs to assure that the best and most current technical information available is made use of in carrying out the work of the Engineering Branch.

2. Reviews the mechanical portion of Architect-Engineer (A-E) design submittals, and advises on soundness and completeness of design, conformance to U.S. Navy criteria, functional adequacy, and reasonableness of A-E estimates. Perform construction inspections on all completed mechanical work.

3. Coordinates with representatives of station departments and tenant activities on engineering study and/or work request, and prepares preliminary mechanical designs sketches, schematics and cost estimates required for planning, budgeting and design funding of various types of projects.

4. Coordinates with Facilities Management Division (FMD) and Engineering Technicians (ET)/Quality Assurance Evaluators (QAE) of Facilities Engineering & Acquisition Division (FEAD) Atsugi and advises on technical problems brought Engineering Branch Manager in connection with contract drawings and/or specifications. Reviews and replies to Request for Information (RFI) and Field Adjustment Request (FAR) from contractors on technical problems at construction sites.

Performs other related duties as directed.

Other requirement - Member may be required to enter and work inside of a confined space.
