6. 職務内容 Duties

Conducts onboard investigation as to the project outlined in Job Orders. Checks subject machinery, equipment or its surroundings for their actual condition or existing troubles, and collects detailed information of their technical requirements. Develops designs and plans, and performs engineering calculations for modification, relocation and installation of ship's propulsion machinery and auxiliary equipment of various types in the assignments where highly complex and unusual problems are infrequently involved. Analyzes the information obtained in the investigation along with the data furnished by Job Order, and grasps technical requirements and problems involved in the project. Collects and studies applicable data from various resources, e.g. technical manuals, specifications, and instructions to examine the work requirements in light of Naval engineering/mechanical standards, criteria or guidelines. Performs technical calculations, determines most suitable and effective plans and layouts, for the project, and provides specifications of the projects including materials and parts to be used and technical notes. Keeps close contacts with shop's personnel as well as ship's representatives in progress of design work. Confers with technicians and engineers in other sections, providing technical information and advices. Performs other duties as assigned.

- d. Skill in operating personal computer such as Microsoft Word, Excel, Outlook, and Power Point, etc.
- e. Ability to make measurements, compute, read engineering drawings and specifications, and to design assigned projects.

1-5: a. One year of clerical, technical, or administrative work experience equivalent at 1-4 level in the related work, **OR** completion of 4-year college/university in a related field may qualify him/her at 1-5 level.

1-4: a. One year of clerical, technical, or administrative work experience in any field, **OR** completion of 4-year college/university in any field may qualify him/her at 1-4 level.
