Registration Dates: (Registration is at Youth Center, bldg 4485, from 1600 -1800 on the following days.)

- 16 April: SAC families
- 17-18 April: Single and Dual Military
- 19-20 April: Active Duty Military, including Reserve on orders, with a full time working spouse or a full time student spouse. (Spouse pay stubs or verification of full time school load will be required.)
- 23-24 April: DoD Civilian: Single or with a working Spouse.
- 25-26 April: Contractors: Single or with a working Spouse.

Note: Spots are assigned based upon priority set up by DoD. Registration dates follow this priority. A waiting list will be established in the event all spots are full before registration ends. Waiting list will go in order of priority, not first come first serve.

Documents Required at Registration:

- Completed registration package (Forms, checklist, enrollment, Registration 1700/04, Health Information, Child Information, Authorization Form, USDA Form, DD Form 2652) *** Parent Fee Agreement will be completed at the Youth Center and you will be called back to sign and pay deposit once Total Family Income has been calculated.
- Current LES/Paystub from Sponsor. For full Time working spouse please submit a current LES/Paystub and for full time student spouse please provide in writing on letter head from the school in which they are attending verification of full time studies. ****Please note that if paystubs are not provided you will automatically be placed into the highest category and must still show proof of a full time working/full time student spouse.**
- Verification of Eligibility: All sponsors must show either their Military ID or Civilian CAC Card and present their child's birth certificate.
- Dual and Single Military: Please bring a copy of your current Family Care Plan.
- If your child(ren) has any allergies to food or medication or any special needs- Additional paperwork will be given to you at the time of registration and all paperwork must be returned within 2 weeks.

Rules:

- All Forms must be signed by the sponsor or by POA for the sponsor. If signing by POA a copy of the POA must be provided.
- The sponsor must be at registration to register the child. ****This is due to the fact that the sponsor must sign the Parent Fee Agreement.**
- Age Requirements: at least 5 and have completed Kindergarten going in to the First Grade up to the age of 12.
- Children turning 13 in the summer may attend camp until their 13th birthday.
- Deposit is required per child for placement. See Enrollment form for deposit details.
- All Forms must be completely filled out. If a section is left blank we will ask you to complete it at registration which can hold up the process.
